FURTHER EXTENSION OF WAIVER FROM STRICT COMPLIANCE WITH RULE 14.41(A) OF THE LISTING RULES

References are made to the announcements of Huajun Holdings Limited (the “**Company**”) dated 6 March 2018, 19 March 2018, 7 May 2018, and 1 June 2018 in relation to the acquisition of (i) the entire equity interests in Wuxi Huiling Real Estate Co., Ltd.*; (ii) the entire equity interests in Wuxi Huiyuan Real Estate Co., Ltd.*; and (iii) 55% equity interests in Wuxi Huize Real Estate Co., Ltd.* (the “**Announcements**”). Capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements unless the context requires otherwise.

As disclosed in the announcement of the Company dated 19 March 2018, the Company applied to the Stock Exchange for the Waiver and the Stock Exchange granted the Waiver to the Company on the basis that the Company would despatch the Circular on or before 30 April 2018.

As disclosed in the announcement of the Company dated 7 May 2018, the Company applied to the Stock Exchange for an extension of the Waiver and the Stock Exchange extended the Waiver on the basis that the Company would despatch the Circular on or before 1 June 2018.

As disclosed in the announcement of the Company dated 1 June 2018, the Company still needs additional time to finalise the property valuation report for the assets held by the Target Companies for inclusion in the Circular. It is expected that the despatch date of the Circular will be postponed to a date not later than 29 June 2018.

In view of the above, the Company has applied to the Stock Exchange for a further extension of the Waiver and the Stock Exchange has, on 8 June 2018, granted the Waiver on the basis that the Circular will be despatched on or before 29 June 2018. The Stock Exchange may withdraw or change the Waiver if the Company's situation changes.
