### **INSIDE INFORMATION UPDATES ON PROGRESS OF LITIGATION**

This announcement is made by Huajun International Group Limited (the “**Company**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 28 June 2018 and 11 March 2019 (the “**Announcements**”) in relation to various legal proceedings (“**Legal Disputes**”) initiated by Jiangsu Nantong Erjian Group Company Ltd.\* (江蘇南通二建集團有限公司) (“**Jiangsu Nantong**”) as plaintiff against various subsidiaries of the Company in the People’s Republic of China. Unless otherwise defined in this announcement, all capitalised terms used herein shall have the same meanings as those defined in the Announcements.

The Company would like to update the Shareholders and the potential investors of the Company in respect of the progress of the Legal Disputes as follows:

#### **CLAIM A AND CLAIM B**

Claim A and Claim B have been settled and the order, if any, previously granted by the Shanghai Court to freeze and preserve certain land parcels owned by the relevant parties have been released.

## **CLAIM C**

Jiangsu Nantong has agreed to settle the Claim C with Dalian Haitong and Huajun Dalian. Jiangsu Nantong had applied to the Liaoning Intermediate Court for withdrawal of the Claim C and the Claim C had been withdrawn.

## **CLAIM D**

Jiangsu Nantong has also agreed to settle the Claim D with Dalian Haitong and Huajun Dalian. Jiangsu Nantong have applied to Liaoning High Court to release the order for freeze and preservation of certain assets owned by Dalian Haitong as Dalian Haitong has made certain progress payments to Jiangsu Nantong on or before 30 June 2019 pursuant to the agreement between Jiangsu Nantong and Dalian Haitong. In addition, Jiangsu Nantong has agreed to continue the construction services for Dalian Haitong.

## **CLAIM E**

Jiangsu Nantong has agreed to settle the Claim E with the relevant parties. Pursuant to the agreement between the parties, Jiangsu Nantong has applied to the court for withdrawal of Claim E as Dailian Haitong has made certain progress payments to Jiangsu Nantong on or before 30 June 2019.

As at the date of this announcement, all claims raised by Jiangsu Nantong against various subsidiaries of the Company had been withdrawn,
