POLL RESULTS OF THE SPECIAL GENERAL MEETING HELD AT 3:00 P.M. ON FRIDAY, 6 DECEMBER 2019

The Board is pleased to announce that the Resolution was duly passed as an ordinary resolution by the Independent Shareholders by way of poll at the SGM held on Friday, 6 December 2019.

Reference is made to the circular (the “**Circular**”) of Huajun International Group Limited (the “**Company**”) and the notice (the “**SGM Notice**”) of the special general meeting (the “**SGM**”) of the Company dated 11 November 2019. Unless otherwise specified, terms defined in the Circular shall have the same meanings when used in this announcement.

POLL RESULTS OF THE SGM

The Board is pleased to announce that at the SGM held on 6 December 2019, the proposed resolution (the “**Resolution**”) as set out in the SGM Notice was duly passed by the Independent Shareholders by way of poll as an ordinary resolution (with more than 50% of the votes cast in favour of the Resolution). <p>(a) to approve, confirm and ratify (i) the conditional subscription agreement (the “Subscription Agreement”) (a copy of which has been produced to the Meeting marked “A” and initialed by the chairman of the Meeting for identification purpose) dated 16 August 2019 and entered into between the Company and China Huajun Group Limited (“CHG”) in respect of the subscription (the “Subscription”) for the convertible bond (the “Convertible Bond”) in principal amount of HK\$1,000,000,000 to be issued by the Company, and the transactions contemplated thereunder; (ii) the terms and conditions of the instrument of the convertible bond (the “Instrument”) to be executed by the Company in relation to the Convertible Bond to be issued by the Company to the Vendor or its nominee under the Specific Mandate (as defined below), (a copy of which has been produced to the Meeting marked “B” and initialed by the chairman of the Meeting for identification purpose), subject to the completion of the issue of the Convertible Bond pursuant to the terms and conditions of the Subscription Agreement, which are convertible into 26,315,789 new shares of the Company pursuant to the Instrument at the initial conversion price of HK\$38.00 per share (subject to adjustments); (iii) the grant of the specific mandate to the Directors to issue the Convertible Bond and to issue and allot the Conversion Shares to CHG pursuant to the Instrument (the “Specific Mandate”); and</p> <p>(b) to authorise any one or more of the Directors to do all such acts and things and execute all such documents which he/they consider necessary, desirable or expedient for the purpose of, or in connection with, the implementation of and giving effect to the allotment and issue of the Convertible Bond to CHG.</p>	<p>47,260 (100%)</p>	<p>0 (0%)</p>

- (1) the total number of issued Shares was 61,543,075 Shares;
- (2) CHG, Mr. Meng and their respective associates hold 45,229,779 shares in aggregate, representing approximately 73.49% of the issued share capital of the Company. CHG, Mr. Meng and their respective associates abstained from voting on the relevant resolution(s) at the SGM accordingly;
- (3) there was no Share entitling the holder to attend and abstain from voting in favour of the Resolution at the SGM pursuant to Rule 13.40 of the Listing Rules;
- (4) save as disclosed, there was no Shareholders that are required under the Listing Rules to abstain from voting;
- (5) the total number of Shares entitling the Shareholders to attend and vote on the resolution at the SGM was 16,313,296 Shares, representing approximately 26.51% of the issued share capital of the Company; and
- (6) the Company's branch share registrar in Hong Kong, Union Registrars Limited, acted as the scrutineer for the vote-taking at the SGM.
